Volunteer understands that this Release discharges CARS from any liability or claim that the Volunteer may have against CARS with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with CARS, whether caused by the negligence of CARS or its officers, directors, employees, or volunteers or otherwise. Volunteer also understands that CARS does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

### **MEDICAL TREATMENT:**

Volunteer does hereby release and forever discharge CARS from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with CARS.

### **INSURANCE:**

The Volunteer understands that CARS does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

### **PHOTOGRAPHIC RELEASE:**
